TERMS

1. MINIMUM 50% DEPOSIT REQUIRED DUE AT SIGNING OF THIS CONTRACT. CHECKS SHOULD BE MADE PAYABLE TO **CURTIS KLINE**. DEPOSITS ARE NON-REFUNDABLE.
2. BOTH PARTIES ENTERING INTO THIS CONTRACT ARE PERMANENTLY BOUND TO FULFILL ALL OBLIGATIONS OF THIS AGREEMENT UNLESS ONE OR MORE OF THE FOLLOWING CONDITIONS APPLY:
 - a. BOTH PARTIES MUTUALLY AGREE TO LEAVE THE AGREEMENT AND ITS RESPONSIBILITIES
 - b. THE EVENT DESCRIBED ABOVE IS COMPLETELY CANCELLED, WITH A MINIMUM OF 30 DAYS NOTICE
3. IN THE EVENT CURTIS KLINE BECOMES UNABLE TO PROVIDE SERVICES DUE TO UNFORSEEN CIRCUMSTANCES, A SUITABLE REPLACEMENT SHALL BE PROVIDED.
4. ALL DETAILS FOR THE PERFORMANCE MUST BE FINALIZED FIVE (5) DAYS BEFORE THE PERFORMANCE.
5. CURTIS KLINE SHALL NOT BE LIABLE FOR ANY ACTION(S) ARISING FROM OR IN CONNECTION WITH ANY INDIVIDUALS NOT DIRECTLY AFFILIATED WITH CURTIS KLINE. FURTHERMORE, PARTIES CONTACTING CURTIS KLINE AGREE TO ASSUME FULL RESPONSIBILITY FOR ANY AND ALL DAMAGES CAUSED BY THEMSELVES OR THEIR GUESTS REGARDING ANY OF CURTIS KLINE'S EQUIPMENT.
6. LOCATION OF EVENT – IF OUTDOORS, PROPER SHELTER SHALL BE PROVIDED TO SHIELD CURTIS KLINE'S EQUIPMENT AND PERSON FROM HARSH ELEMENTS SUCH AS RAIN, SNOW, ICE. ALL VENUES MUST PROVIDE A FLAT SURFACE AND TABLE (AT LEAST 3 FT LONG X 2 FT WIDE) FOR TEMPORARY PLACEMENT OF EQUIPMENT. ELECTRICITY MUST BE AVAILABLE WITHIN 20 FEET OF THIS AREA. ELECTRICAL CIRCUIT SHALL HAVE A MINIMUM OF 20 AMPS POWER RATING.
7. CURTIS KLINE SHALL NOT BE LIABLE FOR LOSS OF POWER NOR CATASTROPHIC EQUIPMENT FAILURE DURING THE EVENT. A SUITABLE REPLACEMENT SHALL BE RENDERED AT THE REQUEST OF THE CLIENT. IN THE EVENT OF TOTAL POWER FAILURE FOR A PERIOD GREATER THAN ONE HOUR AT THE SITE, THIS CONTRACT SHALL BECOME VOID AT THE REQUEST OF EITHER PARTY.
